This suggestion was discussed. The League Day chair had tried the Handicap Index pairing method as an experiment. This will not be implemented. League Day pairings continue as before with foursome of mixed handicaps.



Suggestion: Alternate pay options for tournaments, etc. Zelle as an example.

This suggestion was very timely. SBRWGA Treasurer, Kathi Dyer has already worked with the bank to set up the ability to use Zelle as a payment method. A process for the payment method is being created (to include an instruction flyer) and this option will be implemented with the next event.
